

MURA Board proposes bylaw updates

READERS MAY RECALL that the board conducted the Spring 2020 officer elections by electronic ballot after the membership's annual meeting was canceled due to COVID-19. This was conducted under provisions in the MURA Bylaws that permit the board of directors to direct the activities of the organization between meetings of the membership, especially in extraordinary circumstances.

Interestingly, it is probably safe to say that more members participated in that email election – a total of 225 ballots – than in most in-person elections held at a regular meeting.

To make any future electronic balloting less of an exceptional event, the board has approved a bylaw change that will codify a procedure for the future possible electronic election of officers and for voting on any other ballot measures.

In reviewing the bylaws, the board also approved a change to permit the existence of co-chairs for standing committees. Currently the bylaws require a sole chair appointed for each committee. This change will permit more flexibility in providing leadership for a committee that, for one reason or another, might have a difficult workload.

Bylaw changes must be approved by a vote of the entire membership. This will be considered at the next in-person meeting when such a vote can be taken. Of course, the precise wording of the proposed additions will be distributed before such a meeting. Any of your officers will be happy to discuss the purposes of these changes with you.

The board also decided to prepare a “Policies and Procedures Manual” containing MURA’s “standard operating procedures” and policies established by the board and the membership that do not fall into the broad categories of bylaws or constitutional issues.

As always, your comments and suggestions are welcome.

Osher's goal is lifelong learning. It is one of MURA's priorities, too. The first venture in MURA's partnership with Osher in July was an outstanding presentation by Dr. Andrew Clarke of CAFNR. More than 60 people attended the Zoom gathering.

Osher members have been invited to join our virtual September Breakfast Meeting with David Sapp. MURA also will partner with Osher for September's Fall Social and October's Legislative Forum.

Osher Lifelong Learning Institute at MU transitioned to online right away. It finished the Spring Semester and continued through the summer session on Zoom. Starting on Sept. 21, the 2020 Fall Semester will offer more than 20 classes on Zoom. Members of the Osher staff have become “Zoom experts” and are happy to help you personally so that you are comfortable participating.

Scientists face challenges in food production

DR. ANDREW CLARKE, associate professor of Food Science and UM Presidential Fellow, addressed “How Food Scientists are Changing the Way We Feed the World” at the July 14 online MURA meeting.

Clarke identified achievements in food science and technology as well as the challenges ahead. As Clarke explained, food is complicated — as are consumers, agriculture and regulations.

Missourians can help meet the challenges by using value-added agriculture experience and investing in the Missouri Food, Beverage and Forest Products Initiative, he said.

Sixty-four viewers tuned in for this “breakfast presentation” by Zoom conferencing that allowed questions and answers. The meeting was joined by viewers from across the state of Missouri and other states, as well.

Retiree milestones from 2000 - 2010

2000-01: John Bauman is MURA president. John kept a diary every day for 70 years.

2000: Ann Gowans writes a column for the MURA Newsletter called "The Aging Front." Gowans continued her column until 2015.

2000: Rod Gelatt leads trivia quiz at holiday luncheons. Gelatt led the quiz until 2014.

2001: John Parker begins Lifespan Learning Program.

2002: MURA President G.B. Thompson, "Santa's Chief Elf," begins tradition of membership involvement in Santa's gift giving at the annual Holiday Luncheon.

2002: Tom Brown receives Faculty Retiree of the Year. Brown chaired the Committee for the Chancellor's recognition of retirees for many years.

2004: Charles Cramer serves as MURA president.

2004: Tim Rooney is MURA Seniors Golf Champion in "arguably the most popular local tournament over the past 30 years."

2005: John Rhein is acknowledged for providing leadership in the production and distribution of the MURA Newsletter and directories for 15 years.

2005: MURA Past-Presidents Club was initiated by Charles Cramer, MURA president in 2004. (Today, it is a MURA standing committee, led by Tom Henderson.)

2005: Jo Behymer is Faculty Retiree of the Year for service to university, other educational institutions and to religious and civic organizations.

2005: Darlene Miles is Staff Retiree of the Year for service to Missouri State Senior Games, Philanthropic Educational Organization and to her church.

2005: Lucille Salerno begins service as director of Lifespan Learning Program with a \$100,000 Osher grant. (It is later renamed the Osher Lifelong Learning Institute at MU.)

2006: Rod Gelatt is MURA president.

2006: Darlene Schroeder is Staff Retiree of the Year. Darlene worked for President Elmer Ellis, and since retirement helped recruit, train and assign volunteers for MU's track and field programs.

2006: Verna Rhodes is Faculty Retiree of the Year. She worked with "A Call to Service" and developed relationships between the MU School of Nursing and the School of Nursing in Tbilisi, the capital city of Georgia.

2007: Jo Behymer serves as MURA president.

2007: Proclamation renames MURA annual picnic as Ray Schroeder Picnic.

2007: Max Miller is Faculty Retiree of the Year because of his work with Habitat for Humanity, Optimists, Rainbow House, Show-Me State Games and 4-H among others.

2007: Gary Smith is Staff Retiree of the Year. He served as 2003 MURA president and on numerous boards including the Alzheimer's Association, Boone County Cancer Society, Boone County Historical Society, Boy Scouts, United Way, Kiwanis, Jefferson Club and University Club.

2007: John Parker begins MURA's breakfast series with Bob Priddy, news director of Missourinet as the first speaker. His presentation was "A Mosaic of Missouri History." (Parker continued in this role until 2017.)

2007: MURA Board of Directors approve a resolution supporting Chancellor Brady Deaton's proposal to rename the Missouri's flagship university as the University of Missouri (eliminating University of Missouri-Columbia as the name). Curators approve the name change on Nov. 29, 2007.

2007: Since 2000, retirees provided \$25.3 million of the \$34.5 million contributed by faculty, staff and retirees in the For All We Call Mizzou Campaign.

2007: The MURA Investment Club, founded in May 1997, dissolves on Sept. 25. Robert Breitenbach was the first president, and Amy Preckshot was the first treasurer. The MURA Personal Finance Group was the impetus for the creation of the Investment Club.

2008: Rod Gelatt is Faculty Retiree of the Year. Gelatt was a pioneer of Public Television and KOMU, known for his wit and melodious voice on "Views of the News."

2009: Ernest Hildebrand is Staff Retiree of the Year for work on the MURA database, Kiwanis, Habitat for Humanity, Cleanup Columbia and crafting toys for Ronald McDonald House.

2009: James Creed is Faculty Retiree of the Year for work in veterinary medicine, Optimist Club, Mormon Church and Boy Scouts.

2010: With Earl Wilson's leadership as MURA treasurer, the IRS approves MURA as 501(c)(4) tax-exempt organization.

2010: Robert Marshall is Faculty Retiree of the Year. He is known as the father of Mizzou's signature Tiger Stripe ice cream flavor. He serves at university, community, state and national levels.

2010: Joyce Lake is Staff Retiree of the Year. She is the first charitable gift annuity donor to the university. She volunteers at university and community levels.

Communication: A core objective for MURA

More than 250 retirees crowded the Animal Sciences Auditorium at 2 p.m. on March 30, 1990, for the UMC Retirees Association Founders' Day.

Dr. Robert Daniel spoke of the need for an organization to represent retirees, and Clarence Verl "C.V." Ross called for a motion to organize such a group. He then introduced a proposed constitution and bylaws to establish what we know today as MURA. Ross was elected as the first president of the UMC Retirees Association.

Whether gathering retirees in an auditorium or contacting them through an array of paper and electronic media, communication has always been a central constitutional objective for MURA: *"To serve as a channel of communication between retirees and the University and with other appropriate groups and individuals"* (Article IV – Objectives, Sect. 3).

The organization's name was changed to MU Retirees Association or MURA in 1992.

Communication Vehicles

Mailed newsletters dating back to 1990 archive MURA's history. John Rhein provided the leadership in the production and distribution of MURA newsletters and directories for 15 years, from 1990 to 2005. Black and white photos and then color photos emerged in newsletters as the masthead changed over the years to capture activities and the business of the organization.

The types of communication also changed over the years as electronic media became more accessible. To reach members in the most efficient manner, today, we have expanded methods to reach members, including:

- Newsletters – mailed and emailed
- Facebook posts with photos
- E-mail blasts every two weeks
- A website with links for further information
- Video recordings of annual Information Meeting
- Promotional fliers for recruiting members
- UM Connection email for the four-campus' retiree associations
- Webinars and Zoom conferencing and programs

Two-way communication

MURA emphasizes two-way communication for shared governance. Many people are actively involved in the MURA Board and committees, monthly breakfast series, MURA Past-President meetings, four-campus retirees associations' meetings and meetings with MU and UM administration. We have both faculty and staff ombudpersons and opportunities to hear from members at the Spring Annual Business Meeting and Fall Information Meeting.

In 2018, a statistical survey, led by Art Jago, was launched to receive member feedback on MURA's performance in meeting its objectives. The survey gave MURA members the opportunity to anonymously provide their views about the programs and activities that MURA offers and how well we are representing their interests within the larger MU community.

Equally important, the survey provided members with an opportunity to suggest future programming and how MURA might better meet members' needs. Communication during the 2020 pandemic

Due to the COVID-19 precautions, MURA has adjusted its communication methods in 2020. The Membership Committee initiated the "Friendly Voices" program using the reliable telephone to reach members without Internet access. Thirteen MURA volunteers attempted 147 phone calls, reaching approximately 100 MURA members or family members. Members who received calls were positive, appreciative and glad to hear from MURA.

The Internet has been heavily used during this Covid-19 time period as we are sheltering at home. The election of officers was conducted through an online Survey Monkey ballot in April. Then in May of this year, MURA initiated a four-campus webinar among UM retirees with tremendous participation.

What does MURA's future look like in terms of communication? Barb Harris, Communication Standing Committee Chair, reports that in the seven years she's served in this position, it is easy to say things have drastically changed and going forward will be no different.

MEET JO BEHYMER:

The woman who gets things done — with goodness and efficiency

The adage "When you want something done, ask a busy person" exemplifies Jo Behymer. We feature Jo Behymer in this newsletter to honor her and to reflect on the second decade of MURA.

In 2007 Jo Behymer became the second woman to serve as a MURA president. Diane Brukardt was the first woman MURA president in 1999.

Who is Jo Behymer?

Jo Behymer's academic career demonstrates how she was continuously singled out to lead. She began teaching business education in the College of Education in 1962 and served in various positions in the College of Education concluding in 1990 as associate dean of research and graduate studies under Gerald Brouder. She retired from the Provost Office in 2000 under Brady Deaton.

During that time, she had numerous responsibilities with the Honors College, Writing Program, International Center, Academic Support Center, Service Learning, Student Conduct, Faculty Grievances, Sexual Harassment and represented the Chancellor's Office and Provost Office in lawsuits.

Few may know that Jo Behymer was the academic adviser to Nan Erickson – MURA's next woman president in 2011. Nan says Jo "radiates

goodness. To many, she is a loving friend, a confidante, a tough cookie when she needs to be and is a 'finisher' as she completes any task given."

An example, Nan says, occurred on the day of Nan's Ph.D. hooding ceremony. That morning Nan's husband, a College of Education Department chair, said he wanted to "help" in the hooding.

As Nan explains, "I reminded him that the ceremony was due to happen in just a few hours; it was too late to change any plans. However, he insisted, so finally I called Jo and told her his wish. She said that she would take care of the request and take care of it she did."

Nan says Jo "made it happen" for many students, staff and faculty during her tenure at MU. "Her goodness is naturally a part of her, and I am honored to be a recipient of that goodness!"

Jo Behymer's capabilities and charisma extend beyond the ivory tower. The number of community organizations benefiting from her leadership is mesmerizing. The list includes the Central Missouri Food Bank, Columbia-Boonslick Kiwanis, Columbia Public School, SuccessLink, Elder Care and more. It's easy to wonder: How does she do it?

Rose Porter, the fourth woman MURA president serving in 2012, adds a story about Jo that reveals the answer.

"Jo was always the model of efficiency," Rose says. "She knew how to get people on board and get the train moving in the right direction. She was a master conductor who worked so well with her colleagues, staff, students, administrators.

"She retained this efficiency even after she retired. She was a key figure in the Olivet Church's annual fundraiser BBQ. It was a big undertaking, and every member of that church contributed their time and energy and resources to make sure it was a success."

"Jo's job was to sell as many tickets as possible. When asked, we always purchased two tickets and always enjoyed the delicious food. But upon her retirement, she wasn't around to physically corner us to purchase the tickets. Still determined to sell us tickets, she simply mailed us two tickets with a return envelope to mail back our check."

Reflections

MURA was well served to have Jo as president in 2007. She reflects on that experience: "When I was asked to be one of the early MURA female presidents, I knew the group I was joining was mostly men, many from CAFNR. This did not concern me because of my previous experiences, but I did have several surprises. I was familiar with the committee structure, but I did not realize until I asked the chairs for a list of members that the chair WAS THE COMMITTEE with only one exception.

"As a firm believer that involving members in any group is key to retaining members, I began asking faculty and staff members with diverse backgrounds to serve on committees. Almost everyone agreed to serve, but Wayne didn't eat very well that month.

"One of the goals was to increase membership, so I sought a chair who knew many people, was outgoing, organized and willing to work. Roger Mitchell accepted the position and exceeded even my expectations. Membership that year grew by leaps and bounds in large part because of Roger's leadership and the effort of the Membership Committee working together.

"Fellowship is an important part of MURA. Many of the friends I made the year that I was the MURA president have remained friends, and I treasure them and that time in my life." ■



MURA budget holds steady

THE MU RETIREE ASSOCIATION has ended the fiscal year 2020 with a cash balance on hand of \$6,274.19 and investments with Vanguard in the amount of \$91,303.40. Revenues during this past year were 97.9% of budget while expenses were 116.7% of the anticipated budget.

Lifetime dues paid by our members and additional funds set aside by MURA during prior years comprise the investments with Vanguard. The income from the Vanguard account is used to fund MURA activities during the year. The interest we anticipate receiving this year represents 44% of the operating receipts budget. See Financial Report on Page 10.

The amount held as principal at Vanguard may also be used for special initiatives or objectives as determined by the MURA Board. During 2020, \$4,000 was used as a matching fund incentive during the MURA \$30/30 fundraising campaign for the Kitty Dickerson MURA Scholarship at the university. In June, \$2,800 (the amount collected this year as lifetime dues) was reinvested in the Vanguard account.

The past year was filled with numerous social gatherings, concert fundraisers and celebrations, which kept me busy as the treasurer. Fiscal year 2021 will be off to a slower start regarding the financial activities of the organization, but once we are confident to gather again, MURA will be planning many in-person social and informational events to make up for lost time.

During pandemic, MURA reaches out with “Friendly Voices”

FOR SOME RETIREES, the pandemic and shutdown of programs has resulted in feelings of loneliness and isolation. This has been particularly true for persons who are homebound or who lack internet access.

In June, MURA's Membership committee launched “Friendly Voices,” an effort to make telephone contact with the roughly 150 MURA members who did not have an email address on file. Thirteen MURA members volunteered to help.

After orientation via Zoom, volunteers completed nearly 100 calls to MURA members. Those contacted were positive and appreciative and said they were glad to hear from MURA, with comments such as “I love the newsletter” and “very informative and objective.”

Volunteers who made the calls said they also enjoyed the conversations. To quote Doris Littrell: “It was fun!”

MURA volunteers were: Bob Bailey, Anne and Brady Deaton, Judy Elliott, Betsy Garrett, Art Jago, Julie Kalaitzandonakes, Ina Linville, Doris Littrell, Karma Metzgar, Dick Otto, Margie Sable, Gary Smith, Jo Turner and Kathy Windmoeller.

The “Friendly Voices” project netted 17 new emails, four address changes and eight notices for deceased members.

Current membership in MURA totals 961. There are 58 members who last paid annual dues for 2019 that are receiving “friendly reminders” that they need to renew their membership. There are 52 members who hold annual memberships for 2020 and beyond. If someone sends in payment for an annual membership and they are current in their dues, we simply extend their membership beyond the current year.

As has been the case for many years, the vast majority – 851 – of our members are “life” members.

Thanks to Gary Smith for recruiting our newest life member who is joining as a pre-retiree. Anyone age 55 or older and fully vested in the University Retirement Plan is eligible to join MURA.

At this time when folks are retiring without the benefit of a retirement reception, I would suggest that you consider giving them an annual membership in MURA as a retirement gift! Just think, a retirement gift that does not need to be dusted!
