Begun in 1990, the Chancellor's Retiree of the Year Awards focus on the accomplishments of former employees, after their retirement. These accomplishments may involve volunteer service to the University, civic and welfare services, career and professional activities, or other noteworthy achievements. Accomplishments prior to retirement are not considered in the selection process.

Two awards will be given: one to a faculty member and one to a staff member. Each award includes a plaque and a \$1,000 check.

### Criteria for Candidates

- Nominees must have retired from the University before January 1, 2014.
- Recipients are expected to attend the annual Chancellor's Retiree luncheon to receive the award.
- Retiree Advisory Committee members are not eligible.

# Preparing for health benefits enrollment

As we prepare for our annual enrollment process, the Office of Human Resources encourages you to get to know your coverage and double-check your contact information so you can ensure you're getting up-to-date information about the insurance plan that works best for you.

## **To do: Understand your current coverage and your options**

There will be no benefit changes to medical plans for retirees this year. University-sponsored, self-insured health plans through United Healthcare will be available to retirees and dependents who are not yet Medicare eligible. Medicare-eligible retirees and dependents will continue to receive coverage through the United Healthcare Medicare Advantage plans. In addition, there will be no changes in coverage for the dental or vision plans. Both dental coverage through Delta Dental and vision coverage through EyeMed will continue at the current level.

In October, you will receive a Personalized Benefit Statement that will outline the benefit programs in which you and your dependent(s), if applicable, are currently enrolled. It will also include the 2019 monthly benefit premium rates, as well as rates for any alternate medical plans for which you or your dependent(s) may be eligible.

The Retiree Annual Enrollment period is Oct. 29 to Nov. 9.

If you are satisfied with your current enrollments and would like to continue to receive the same coverage in 2019, no action is required on your part. If changes are needed, they must be made during this period. Information on how to enroll will be provided in your benefit statement.

## **To do: Double-check your contact information**

Our office is working to ensure we have correct home and mailing addresses on file. Please review and update your contact information in myHR: <https://myhr.umsystem.edu>. Revise your information in myHR, or contact the HR Service Center at (573) 882-2146 or [hrservicecenter@umsystem.edu](mailto:hrservicecenter@umsystem.edu) to request a form to update your address, if necessary.

## **Information on insurance coverage for vaccinations**

Some MURA members have inquired about co-pays on various immunizations, such as flu, pneumonia, Hep B and shingles vaccinations.

Thanks to Carol Wilson, UM System Human Resources Director, Health Benefits for providing the following information to sort out insurance coverage.

The University Medicare Advantage plan covers the flu, pneumonia & Hep B vaccinations under Medicare Part B. However, not all pharmacies have the ability to bill Part B. For a summary of pharmacies that can bill Medicare Part B, see the list provided by UHC at [www.uhcflu-locator.com](http://www.uhcflu-locator.com). Be sure to ask the pharmacy you are using whether it can bill to Part B. If it cannot, you may save part or all of the co-pay by going to a pharmacy on the list.

Shingles vaccinations are covered under Part D, and, in most instances, there is a RX copay and an administrative fee associated with this vaccination.

If you have United Health Care coverage and have been billed for an item that is covered, you may complete a form for submission to UHC for reimbursement. The reimbursement form can be found at [www.uhcretiree.com](http://www.uhcretiree.com). Please note, members will need to create an account to receive the form online, or they can call Customer Service at (866) 899-5903 to have a form mailed to them.

## Volunteering for Scholarship

If you're interested in helping to raise money for MURA's Kitty Dickerson Scholarship, the opening of classes at MU offers an easy opportunity.

Retirees can work at the Mizzou Store, the university's bookstore in the Student Center, from Aug. 20 to 24, the week that students return to campus.

There are four shifts per day: 9 to 11 a.m., 10:45 a.m. to 1 p.m., 12:45 to 3 p.m. and 2:45 to 5 p.m. Three people are needed for each shift. You may volunteer for more than one shift during the week.

The bookstore pays MURA \$15 for every hour of volunteer work, which in turn goes toward the scholarship fund. Volunteers at the Mizzou Store during the week of Jan. 15 to 19 to launch spring semester netted \$1,563.75 for MURA.

Volunteering means meeting, greeting and directing people and answering questions from shoppers who are mostly students, basically, whatever needs to be done. Bookstore employees will instruct you about your duties. Wear comfortable shoes. If you already have a red MURA T-shirt, then please wear it to your

shift(s). If you don't have a MURA shirt, the bookstore will provide you with one.

### Reminder

Effective Jan. 1, 2019, the annual MURA membership dues will increase to \$12.50 per year and lifetime membership will increase to \$100. Enroll now for \$7.50 per year or \$75 for a lifetime membership.

## MURA Treasurer's Report

MURA's cash in the operating fund increased by \$4,200 from June 2017 to June 2018 because receipts exceeded cash disbursements by \$1,935 and a transfer from the investment fund was made for \$2,265.

Other observations regarding the financial statements:

Dues increased this year compared to last by \$3,617. Of this increase, \$3,390 was in life-time memberships.

Fees for MURA events are now being collected largely online through the Alumni Spaces portal. The cost to MURA is a 5 percent transaction fee. It covers both the cost to use the Alumni Spaces portal and the credit card transaction fee. The amounts shown on the statement of cash flows are net of this fee.

Since the reports from Alumni Spaces were nonexistent for some of the earlier deposits, when more than one event occurred within the same time period, the distribution of the income was done by use of the registration lists.

The Board authorized a contribution by MURA to the MURA Scholarship Endowment Fund up to \$10,000. This is a matching contribution based on member donations. As of this date, \$5,015 has been matched by MURA. Of this amount, \$2,265 represents MURA's match of member contributions made through Dec. 31, 2017, and \$2,750 was given to match member donations made to the spring social fundraiser. A transfer will be made in July for the member contributions made, outside of the spring social, for the period Jan. 1 through June 30.

(As of July 1, MURA had accomplished the \$10,000 goal, Gary Smith, Scholarship Committee member, reported at the July 18 MURA Board meeting.)

Overall, MURA is in good financial condition. The recent dues increase approved by the membership should place MURA in good financial shape for many years to come.

It has been a privilege to serve MURA for the past two years.
